



Board of Directors Meeting Minutes – June 11, 2011

In attendance: Mike Quam, Dave Boucher, Dave Huenink, Paul Piotrowski, Gene Taurman, Mike Clinnin, Mike Yokofich Absent: Steve Lewis, Neil Besougloff

The meeting was called to order at 7:04 P.M. by Mike Quam.

President- Mike Quam – Welcomed us – nothing to report.

Vice President – Dave Boucher – We have a new member Ed Lieske from Genoa City. Mike Y. made the motion to accept this new member and it was seconded by Mike C. Voted on by the board and approved.

Secretary – Dave Huenink – The minutes from last month did not get sent out so they will be sent out within the week and approved at the next meeting. We have one renewal and one new member, bringing our membership to 269. We have correspondence that includes an event at the Volo Auto Museum, a thank you from the Milwaukee Memorial Day Committee for being in the parade and various news letters from other clubs.

Treasurer's Report – Paul Piotrowski – Paul presented the treasurers report. A motion was made by Mike Y. to approve and seconded by Dave B. Voted on by the board and approved. Dave B. turned in bills for \$88.65 for office supplies and also bills for the over night event. Mike Y. made motion, Gene T. seconded. Voted on by the board and approved. Two checks where turned in for one new member and one renewal membership. The banner and flag purchases were discussed and samples were shown. They group thought they looked great. The hosts, who chair parades, were given one for the beginning and ending cars to display.

Outdoor – Gene Taurman – Cheryl P. is concerned with the cost and number of people for the picnic. It was discussed and determined we will be giving her an estimated number of attendees. Mike Y. will be calling her. The details of the picnic were discussed – food, games etc. Carl Doro mentioned there seemed to be an issue with sign ups for the South Shore event. It was suggested, we talk up events prior to other events. Twenty-eight have signed up for the Wisconsin Rapids reunion. Jan Olsen mentioned she felt it was a little low. In discussion, it was felt the attendance by our club will be good. Dave B. talked about the over night event. Sixty-six people showed up for pizza and sixty-eight for the banquet. Thirty-two hotel rooms were rented.

The Turn Back Time Tour for September 25<sup>th</sup> was discussed with respects to a limit of eighteen people. The article in "Wheeling The A" will be reworded to indicate more then



eighteen can attend the museum and countryside tour. The wagon ride portion of this tour is limited to eighteen because the wagon will be at capacity. We have one outdoor tour in October which still needs a host.

Indoor - Mike Yokofich- All indoor events are covered. We still do not have a contract with St. Aloysius for the indoor events. Three adult and kids gifts are remaining for the indoor events.

Technical – Neil Besougloff – Nothing to report.

Accessories – Mike Clinnin – Nothing other then working on three season jacket.

Awards and sunshine – Steve Lewis - Dan Kane is a grandfather.

Old business –Year badges were mailed out. A suggestion was made to possibly make a donation to the VA in Woods, Wisconsin. They are always looking for funds to help restore the old buildings. It was mentioned Heritage Days was held in June to help raise awareness and funds.

New Business – The Board discussed reducing the Board of Directors to seven members instead of nine – combining Sunshine and Awards and combining the Accessories position with other positions. Tabled until a later date. A discussion was also held regarding the abundance of accessories and how to move these items – possibly reducing the cost to 50% off. Tabled until a later date.

Meeting adjourned at 8:24 p.m. Gene T. made the motion and Dave B. seconded. Approved.

The occassion was a sales promotion tour with the A's and costume group, for the J.C. Penny Company's six stores in the Milwaukee area. The A-bones with signs and the occupants drew attention where ever they went. Some women asked the group if the girls dresses were the new Chemise styl (this led to much fun)

The A's put on 250 miles of city driving during the three day event. Besides driving from store to store, the cars parked in the front of each store for one hour periods (while generaly large crowds gathered to look at both the cars and costumed members near by. All Penny store employees were customed in the gay ninty era customes, the occassion for all this was Penny's 57<sup>th</sup> Annual Sale.

About 50% of Wisconsin Region members and families now have some clothing of the era of their cars. It is hoped by all officers of the club, that all major club activities in the future will include costumes as well as the restored cars.. This adds color and much more fun to all contests and meets (and those flapper dresses ARE nice to look at too)..



## Board of Directors Position Description SUNSHINE AND AWARDS CHAIRMAN

\* Monthly Requirements:

You are required to submit a monthly article to the "Wheeling the A" editor providing an update of Sunshine for the previous month: members who have been hospitalized, passed on, or need some sunshine passed onto them. Be sure to leave out medical details to respect the wishes of the recipient and family.

## A. MEMBER ILLNESS OR DEATH

In the event of a Wisconsin Chapter member's hospitalization or death, the following guidelines as adopted by the Board of Directors on October 16, 1993, should be followed:

- 1. If a chapter member is hospitalized, a card will be sent in the chapter's name.
- 2. In the event of a chapter member's death, a sympathy card will be sent to the family in the chapter's name. Also a \$35.00 donation will be made to the charity requested by the family. If no charity is indicated, a flower arrangement will be sent in the \$35.00-\$50.00 price range.
- 3. In the event of the death of a chapter member's immediate family member {parent / sibling / children or grandchildren} a sympathy card will be sent in the chapter's name.

## B. OUTGOING PRESIDENT'S AWARD

Each year at the Annual Banquet, the outgoing President receives a standardized plaque. The plaque is an 8"xl0" wood board, on which is mounted a gavel, brass tag with President's name and year of office. Recommend seeing Manitowoc Trophy for design layout.

## C. MEET CHAIRPERSON'S AWARD

As recognition for running an activity and to encourage others to do so, the Wisconsin Chapter presents a Meet Chairman's Award. These guidelines adopted by the Board of Directors on December 8, 1979, should be followed:

- 1. With the help of the Indoor and Outdoor Meet Chairmen, you will present a list of candidates to the Board of Directors for approval.
- 2. The Board of Directors must approve the award and its cost.
- 3. This award shall be presented at the annual Banquet and is based on meets of the previous year.
- 4. First time recipients of an award will receive the award on an 8-1/2" x 11" wood plaque with the chapter logo and the recipients name engraved on a large plate at the top. There is room on each plaque for twelve plates marking event(s) chaired by the recipient(s). Each plate measures 7/8" X 2.5". Should a recipient's plaque board become full, a new unmarked board of the same design will be given to hang below the original board. You will have to query the recipient as to his needs. Note. If the recipient is an Indoor or Outdoor Meets Chairman, He/She will be eligible to receive a plate.

Exception: Technical Seminars are not included in the Meet Chairman's list. The Technical Coordinator will present the host of a technical seminar with a framed Certificate of Recognition on the day of the event.

5. It is suggested that Manitowoc Trophy be used as the facility to produce annual awards as they have formats and information from previous years on file.

#### D. ROOKIE MEMBER OF THE YEAR

The Wisconsin Chapter has always encouraged new members to participate in the activities of the chapter. In past years, we have had members join and quickly become involved with the chapters' activities. They worked hard and gave extra effort to benefit all of us in the Wisconsin Chapter. To say thank you to these members, in December 1979 the Board of Directors established a Rookie Member of the Year Award.

- 1. The award shall be a moderate size plaque, with an appropriate inscription.
- 2. Candidates must be members for more than six months, but not greater than 24 months, at the time of award presentation. Candidates shall be selected based on chapter participation and extra effort they have made on behalf of the chapter.

- 3. The Board of Directors will select the recipient from a list of candidates.
- 4. This award may not necessarily be awarded every year.
- E. CONTINIOUS MEMBERSHIP AWARDS
- 1. Ten Year Award
- 2. In recognition of ten consecutive years of membership in the chapter, ten-year membership plaques shall be given. This plaque consists of a standardized plate mounted on a wood back (see photo provided by awards supplier). The recipient's name (don't forget the spouse) is engraved on the plate. This award is presented at the annual Banquet. If the recipient is not in attendance at the banquet, it can be sent to the member.
- 2. Twenty-five Year Award.

In recognition of 25 consecutive years of membership in the chapter, 25-year membership plaques are given. The plaque consists of a standardized plate with an appropriate inscription. The recipient's name (don't forget spouse) is engraved on the plate. This award also includes free one-year local membership for the next year. A letter noting this should be prepared and presented by the Wisconsin Chapter Secretary. (See photo provided by awards supplier for plaque detail.)

3. Thirty-five Year Award.

In recognition of 35 consecutive years of membership in the chapter, ten-year membership plaques shall be given. This plaque consists of a standardized plate mounted on a wood back (see photo provided by awards supplier). The recipient's name (don't forget the spouse) is engraved on the plate. This award is presented at the annual Banquet. If the recipient is not in attendance at the banquet, it can be sent to the member.

4. Forty Year Award.

The 40 year award will be the same as the 25 year award, including one year free local membership for the forty-first year.

5. Fifty Year Award.

In recognition of 50 consecutive years of membership in the chapter, 50-year membership plaques are given. The plaque consists of a standardized plate with an appropriate inscription. The recipient's name (don't forget spouse) is engraved on the plate. This award also includes free one-year local membership for the next year. A letter noting this should be prepared and presented by the Wisconsin Chapter Secretary. (See photo provided by awards supplier for plaque detail.) 50 year members also receive free dinner at the annual banquet.

#### F. APPRECIATION AND RECOGNITION CERTIFICATES

Certificates are given at the Annual Banquet for the following:

- 1. Outgoing Board Members. A Certificate of Appreciation is given to those members who have served on the Board of Directors for two years.
- 2. A Certificate of Recognition is given to those who have served the chapter by:
- a. Chairing on a seminar or tour.
- b. Retiring from a chapter position such as photographer, newsletter editor, and tool keeper. etc.
- c. Other services to the chapter, as decided by the Board of Directors.

## WISCONSIN CHAPTER - MODEL A FORD CLUB OF AMERICA (MAFCA)

- 1 Attend all scheduled Board of Directors' (BOD) meetings.
- 2 Retain all of the accessories inventory; i.e., sample clothing, items for direct sale, etc., storage containers, inventory records, correspondence files, etc., at the home of the Accessories Chairman. Safeguard the chapter provided \$40.00 in change to be used for cash sales activity. Periodically, conduct an audit of the accessories inventory on hand.

NOTE: This position description presumes that the Accessories Chairman has access to a personal computer (PC).

- 3 Display the accessories; sample clothing for size selection, items for direct sale, etc. at all scheduled indoor membership meetings and, as appropriate, outdoor meetings and special events.
- 4 Monthly, report direct sale items sold (with the revenue) and accessory items purchased (with the expense detail), to the Treasurer.

## Ford's Will

ver wonder about Henry
Ford's will - to whom he left
all those millions? If so, you
may be interested in the following
excerpts from the document, which was
made out on February 3, 1936, and
witnessed by two of Ford's secretaries,
Frank Campsall and Rex Waddell:

"I have heretofore provided generously for my wife, Clara J. Ford, and am satisfied that she is now in a position of complete financial independence. I wish my wife to have, however, and I hereby bequeath to her, all of my personal effects in and about our home 'Fairlane,' at Dearborn, Michigan, including all household furniture, automobiles, and everything used in connection with our home; and, further, any other article or articles of a personal nature which she may wish to retain because of the sentimental value."

To the Ford Foundation, Ford left "all of my shares of stock in the Ford Motor Company, which are non-voting shares known as Class 'A' stock, save such as it may be necessary to sell to pay the obligations of my estate ... All of my real estate other than such real estate as may be a part of our home, 'Fairlane,' I give and devise to The Ford Foundation, save such as it may be necessary to sell to pay the obligations of my estate."

The will continued, "I wish to divide all of my voting stock, known as Class 'B' stock, in the Ford Motor Company, into five equal parts to be disposed of in the following manner: I bequeath one of such five parts to my son, Edsel B. Ford ... The other four parts I bequeath for the benefit of my four grandchildren, Henry Ford II, Benson Ford, Josephine Clay Ford, and William Clay Ford ... I give, devise, and bequeath all the rest and remainder of my estate to my son, Edsel B. Ford, and his heirs." Edsel was also named executor of the estate.

Since Edsel died before his father, the senior Ford on June 1, 1943, added a codicil to his will which made his wife the executor of his estate. The codicil was witnessed by Campsall and manufacturing executive Charles E. Sorensen.

In plainer English, Ford left his voting stock in the Ford Company to his daughter-in-law and four grandchildren, his nonvoting stock to the Ford Foundation. The family thus retained control of the firm; and to this day maintains control. Estimates of Ford's estate (which some have equated with the worth of the Ford Company) ranged to \$700,000,000. But the government valued the firm at \$466,141,500 at the time of Ford's death, and the magnate's estate was reckoned at \$80,319,445. The estate included a \$26,500,000 personal bank account and \$20.00 "due from the sale of hay" from a Ford farm.
